NOTICE: A quorum of the Bail Bond Board will be physically present for this meeting at 501 16th Street, Suite 305, Canyon, Texas. One or more board members may join this meeting by videoconference in accordance with Government Code § 551.127.

1. **REVIEW OF MINUTES:** To review and discuss the Minutes of the last meeting held August 23, 2022 and take appropriate action.
2. **REPORTS ON BONDING COMPANIES:** To receive monthly report on bonding companies operating in Randall County. This includes discussion and any necessary action. Lt. Parvin sent out the company reports on Thursday morning. Outstanding bonds are down to \$19.9 million.
