UNLESS A CONTINUANCE HAS BEEN GRANTED, ANY MOTIONS UNDER CCP ART 28.01 SEC 1, SUBPARTS (1) THROUGH (10), THAT REQUIRE A HEARING BEFORE TRIAL THAT ARE NOT FILED BEFORE THE CALL OF THIS DOCKET WILL BE DEEMED AS WAIVED.

All other pretrial motions must be filed and heard by the Court on or before the Friday prior to trial. A MOTION FOR CONTINUANCE CAN ONLY BE GRANTED BY THE JUDGE, EVEN IF AGREED.

ALL OBJECTIONS TO EXPERT WITNESSES AND/OR MOTIONS TO EXCLUDE EXPERT TESTIMONY – INCLUDING KELLY/DAUBERT/ROBINSON MOTIONS MUST BE SCHEDULED AND HEARD AT LEAST 10 DAYS PRIOR TO THE DATE OF TRIAL.

LAST MINUTE DESIGNATION, SUPPLEMENTATION, ETC. WILL NOT BE CAUSE FOR AN EXCEPTION TO THIS RULE.
