- 1. IT IS THE ATTORNEY'S RESPONSIBILITY TO ASSURE THE DEFENDANT'S APPEARANCE AT THE PLEA NEGOTIATION DOCKET. THERE IS A TABLE IN THE JURY ROOM TO CHECK IN. DEFENDANTS ARE REQUIRED TO SIGN IN AS THEY ARRIVE. AFTER SIGNING, DEFENDANT WILL BE DIRECTED TO YOUR DESIGNATED SPACE.**
- 2. YOU SHOULD HAVE RECEIVED AN OFFER ON EACH CASE AND MAY HAVE WORKED CASES OUT WITH THE STATE BEFORE TODAY. AS TO ANY UNRESOLVED CASES, MEET WITH THE PROSECUTOR ASSIGNED TO EACH CASE TO DETERMINE IF AN AGREED PLEA CAN BE ARRANGED.**
- 3. AREAS FOR DISCUSSION WITH YOUR CLIENT(S) APART FROM THE CROWD WILL BE IN THE CENTRAL JURY ROOM AS WELL AS IN THE HALLWAY.**
- 4. ONCE YOU HAVE EITHER WORKED OUT A PLEA OR DETERMINED A TRIAL IS NECESSARY CONCERNING EACH DEFENDANT, GO TO THE 181ST DISTRICT COURT ROOM AND APPROACH THE BENCH WITH YOUR CLIENT AND MAKE A PLEA ANNOUNCEMENT CONCERNING EACH OF YOUR CASES.**
- 5. CASES WHICH ARE TO BE PLED WILL BE DIRECTED TO THE 181ST DISTRICT COURTROOM WHERE THE JUDGE WILL BE CONDUCTING PLEAS.**
- 6. CASES WHICH ARE NOT RESOLVED WILL BE PLACED ON THE TRIAL DOCKET.**
- 7. DEFENDANTS WHO DO NOT APPEAR WILL HAVE THEIR BOND FORFEITED. A FAILURE TO APPEAR AND ARREST WARRANT WILL BE ISSUED.**
- 8. EXCEPT TO ATTEND THE PLEA HEARING, NO DEFENDANT MAY LEAVE THE PREMISES UNTIL RELEASED BY THE JUDGE.**
- 9. FAMILY MEMBERS AND GENERAL PUBLIC MAY NOT ENTER, BUT MAY ATTEND THE HEARING IF A PLEA IS CONDUCTED.**
